The Supreme Court of the Commonwealth has declared our Graded School unconstitutional, which stops the collection of those taxes by which the school has been so successfully and satisfactorily run for the last four years, scattering its undying benefits among the rich and poor, to hundreds of our children. Shall the School be continued, or shall it be closed, and the 530 children now storing their little minds with useful knowledge be turned adrift without the means of education? Feeling that there can be but one answer to this question, we submit that it can be continued only by the **Liberal** subscription of our citizens, (as individuals.)

One of our leading citizens, COL. W. T. BLACKWELL, has most generously come forward and offered to supply the deficiency that may be necessary to run the school for the next term, on condition of our accepting the management.

Your subscription will be called for in four instalments: First, September 1st, 1886; Second, November 1st, 1886; Third, February 1st, 1887; Fourth, May 1st, 1887. In order to retain our present efficient teachers these subscriptions must be made before June the first, as others have offered them places.
